BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF ITRADE PRINTSHOPPE AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY POLOSHIRT WITH PRINT FOR THE TRAINING ON COCONUT PRODUCTION AND MANAGEMENT (3 BATCHES) THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of advocacy poloshirt with print for the Training on Coconut Production and Management (3 Batches) in the amount allocation of **SIXTY-THREE THOUSAND PESOS ONLY (P 63,000.00)**, dated February 22,2024 under PR No. 2024-02-171;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on February 29,2024 under PhilGEPS Ref.No. **10608666**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. AVECILLA TRADING, 2. CEBOOM ENTERPRISES, 3. ITRADE PRINTSHOPPE, 4. SEAWEED INTERNATIONAL EXPORTS INCORPORATED sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 07 March 2024. During the opening of the bid proposal and upon checking of the documentary requirements, AVECILLA TRADING, CEBOOM ENTERPRISES, ITRADE PRINTSHOPPE and SEAWEED INTERNATIONAL EXPORTS INCORPORATED were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that AVECILLA TRADING, CEBOOM ENTERPRISES, SEAWEED INTERNATIONAL EXPORTS INCORPORATED are suppliers from outside the region 7. It was indicated from the PhilGeps posting that the end-user prefers suppliers from within Region 7, this is to facilitate the delivery goods.

Therefore, these suppliers did not met the End-user's requirements, thus they were declared "unresponsive".

WHEREAS, the TWG conducted another careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations of the **ITRADE PRINTSHOPPE**. It was found out by the TWG that the bid proposal/ quotation submitted by **ITRADE PRINTSHOPPE** has been found to be "Responsive";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **ITRADE PRINTSHOPPE** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **ITRADE PRINTSHOPPE** as the Lowest Calculated and Responsive Bidder with a bid amounting to **SIXTY-THREE THOUSAND PESOS ONLY (Php 63,000.00)** for the procurement of advocacy poloshirt with print for the Training on Coconut Production and Management (3 Batches);
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
