

CONTRACT AGREEMENT

AGREEMENT, made this MAR 19 2024 of 2024 between **Agricultural Training Institute - Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines represented by **GRACIA F. ARADO, PhD** (hereinafter called "the Entity") of the one part and **ROWELL CLENUAR** of Purok 4, Poblacion, Panglao, Bohol, (hereinafter called "Provider/Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **VIDEO DOCUMENTATION INCLUSIVE OF SHOOTING, EDITING AND PRODUCTION OF THREE (3) FULL VIDEOS: 1) RCEF EXEMPLARY BENEFICIARY - LSA COOPERATOR; 2) RCEF EXEMPLARY BENEFICIARY - TOT GRADUATE/TRAINER/FACILITATOR; AND 3) VIDEO DOCUMENTATION OF FOOD PROCESSING TO YOUTH OF CLARIN, BOHOL AND TAGBILARAN CITY ENGAGED IN FOOD PROCESSING plus THREE (3) ONE-MINUTE EACH TEASERS and STILL PHOTOS** hereinafter called "Media Production (the works/Services);

WHEREAS, the Provider/Supplier has accepted the Bid by the Supplier for the supply of those goods and services in the sum of SIXTY THOUSAND PESOS (Php 60,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (f) Eligibility requirements, documents and/or statements (Curriculum Vitae, BIR Certificate of Registration);
 - (g) BAC Resolution;
 - (h) Notice of Award of Contract and the Bidder's conforme thereto;
 - (i) Notice to Proceed;
 - (j) Contract documents that may be required by existing laws and/or the Procuring Entity.
3. In consideration of the payments to be made by the Procuring Entity to the Provider/Supplier as hereinafter mentioned, the Provider/Supplier hereby covenants with the Procuring Entity to execute and complete the Works/Services in conformity with the provisions of this Contract in all respects.
4. The Procuring Entity hereby covenants to pay the Provider/Supplier in consideration of the execution and completion of the Works/Services wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
