CONTRACT AGREEMENT



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB



Security, shall likewise form part of the Contract.

In consideration for the sum of One Hundred Ninety-Four Thousand Eight Hundred Eighty Pesos Only (Php 194,880.00) or such other sums as may be ascertained, Copier Source Enterprises agrees to PROCUREMENT OF TONERS FOR HP COLOR LASERJET MANAGED MFP E78228DN FOR JANUARY TO APRIL 2024 (RICE, OA, HVCDP, CORN, LIVESTOCK, O.ESSETS AND CFITF TRAININGS) accordance with his/her/its in
- 4. The Agricultural Training Institute Regional Training Center VII agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
