BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF SANDUGO PRESS MARKETING AND SUPPLIES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF OFFICE AND TRAINING SUPPLIES FOR JANUARY-APRIL 2024 OF LIVESTOCK, CORN, OA, HVCDP & OTHER ESSETS THROUGH ALTERNATIVE MODE OF PROCUREMENT - SHOPPING
(Section 52.1 (b) of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of Office and Training Supplies January-April 2024 of Livestock, Corn, OA, HVCDP & Other Essets in the amount allocation of **FOUR HUNDRED NINETY-NINE THOUSAND SIX HUNDRED FIFTY-THREE PESOS ONLY (P 499,653.00)**, dated February 14, 2024 under PR No. 2024-02-075;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders February 16, 2024 under PhilGEPS Ref.No. **10563297**, and ATI 7 website, reposted under bid bulletin no. **10563297-01 & 10563297-02**;

WHEREAS, in response to the said posting, 1 DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING, 2. DYNAMIC CNG TRADING, 3. O&E OFFICE AND SCHOOL SUPPLIES TRADING, 4. SANDUGO PRESS MARKETING AND SUPPLIES sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 01 March 2024. During the opening of the bid proposal and upon checking of the documentary requirements, DALIKYAT GENTRADE

DRYGOODS TRADING, DYNAMIC GENERAL MERCHANDISE, O&E OFFICE AND SCHOOL SUPPLIES TRADING and SANDUGO PRESS MARKETING AND SUPPLIES were declared “eligible” to participate in the bidding and thus rated as “passed” presented as follows:

O&E OFFICE AND SCHOOL SUPPLIES TRADING	411,209.13	21.50%
SANDUGO PRESS MARKETING AND SUPPLIES	476,928.00	4.76%

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations.

WHEREAS, after having been evaluated with all the proposals, the BAC-TWG findings were: O&E OFFICE AND SCHOOL SUPPLIES TRADING is the lowest calculated bidder but is unresponsive since there was discrepancy with the details of its financial proposal and the end user prefers local suppliers. Further the bid proposal submitted by SANDUGO PRESS MARKETING AND SUPPLIES which was the second Lowest Calculated Bidder has been found to be “Responsive”;

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG’s recommendation and declared SANDUGO PRESS MARKETING AND SUPPLIES as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the SANDUGO PRESS MARKETING AND SUPPLIES as the Lowest Calculated and Responsive Bidder with a bid amounting to **Four Hundred Seventy-six Thousand Nine**



- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.


