- Other contract documents that may be required by existing laws and/or the Procuring iv. Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Eighty-Nine Thousand Five Hundred Fifty-Eight Pesos Only 3. (Php 89,558.00) or such other sums as may be ascertained, Thinking Tools Incorporated agrees to PROCUREMENT OF ICT EQUIPMENTS FOR THE FITS ESTABLISHMENT PROJECT 2024 UNDER RCEF PROGRAM in accordance with his/her/its Bid.
- 4. The Agricultural Training Institute Regional Training Center VII agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
