BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF HARDHAT SONGBIRD INDUSTRIAL TRADES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF PRUNING SHEARS FOR THE CONDUCT OF 3 BATCHES OF LET'S DO COCOHYBRID: TRAINING ON COCONUT HYBRID PRODUCTION THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of pruning shears for the conduct of 3 Batches of Let's Do CocoHybrid: Training on Coconut Hybrid Production in the amount allocation of **FIFTY-TWO THOUSAND FIVE HUNDRED PESOS ONLY (P 52,500.00)**, dated May 15, 2024 under PR No. 2024-05-420;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on May 17, 2024 under PhilGEPS Ref.No. **10864053**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. CSL AGRIVET SUPPLIES, 2. HARDHAT SONGBIRD INDUSTRIAL TRADES, 3. LB2 LABORATORY SUPPLIES sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 22 May 2024. During the opening of the bid proposal and upon checking of the documentary requirements, CSL AGRIVET SUPPLIES, HARDHAT SONGBIRD INDUSTRIAL TRADES and LB2 LABORATORY SUPPLIES were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by LB2 LABORATORY SUPPLIES did not met the required specification. It was indicated on the Request for Quotation (RFQ) that the end-user requires heavy duty, spring with case pruning shears but upon the validation of the supplier through phone, the item that they quoted does not have a casing.

WHEREAS, the TWG conducted another careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations to the second Lowest Calculated Bidder which is the HARDHAT SONGBIRD INDUSTRIAL TRADES It was found out by the TWG that the bid proposal/ quotation submitted by HARDHAT SONGBIRD INDUSTRIAL TRADES has been found to be "Responsive";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **HARDHAT SONGBIRD INDUSTRIAL TRADES** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **HARDHAT SONGBIRD INDUSTRIAL TRADES** as the Lowest Calculated and Responsive Bidder with a bid amounting to **FORTY-SEVEN THOUSAND TWO HUNDRED FIFTY PESOS ONLY (Php 47,250.00)** for the procurement of pruning shears for the conduct of 3 Batches of Let's Do CocoHybrid: Training on Coconut Hybrid Production;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
