**RESOLUTION RECOMMENDING APPROVAL TO ADOPT NEGOTIATED PROCUREMENT:
 AGENCY-TO-AGENCY AS THE ALTERNATIVE METHOD OF PROCUREMENT**

Section 53.5 and Annex "H" D-5 of the 2016 Revised IRR of RA 9184

WHEREAS, as a general rule, all procurements shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, Agency may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, Section 48, Rule XVI: Alternative Methods of Procurement of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, the ATI RTC-7 prepared a Purchase Request with No. 2024-03-223 for the provision of venue rental and accommodation for the Training of Trainers on Participatory Guarantee System Batch 1 with an Approved Budget for the Contract (ABC) of **One Hundred Fifty-Five Thousand Pesos Only (P 155,000.00)**, in accordance with its PMP;

WHEREAS, the end-user has justified that resorting to Negotiated Procurement by Agency-to Agency is more efficient and economical to the government as indicated in the letter/justification to the BAC.

WHEREAS, Section 53.5 of the 2016 Revised IRR allows the procurement of Goods, Infrastructure Project and Consulting Services from another agency of the GoP;

WHEREAS, Annex "H" of the same IRR sets the conditions for the Agency-to-Agency enumerated as follows: (i) The Procuring Entity shall justify that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government (ii) Servicing Agency has the mandate to deliver goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Agency (iii) Servicing Agency has the absorptive capacity to undertake the project (iv) Servicing Agency owns or has access to the necessary tools and equipment required for the project;

NOW THEREFORE, for and in consideration of the foregoing, **We, the Members of the Bids and Awards Committee**, hereby **RESOLVE AS IT HEREBY RESOLVED** to recommend **Negotiated**
