BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF DYNAMIC CNG TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF OFFICE AND TRAINING SUPPLIES FOR MAY TO DECEMBER 2024 UNDER REGULAR PROGRAM THROUGH ALTERNATIVE MODE OF PROCUREMENT - SHOPPING (Section 52.1 (b) of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of office and training supplies for May to December 2024 under Regular Program in the amount allocation of FOUR HUNDRED EIGHT THOUSAND THREE HUNDRED TWO PESOS ONLY (P 408,302.00), dated May 8, 2024 under PR No. 2024-05-402;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders May 11,2024 under PhilGEPS Ref.No. **10843899**, and ATI 7 website;

**WHEREAS**, in response to the said posting, 1 DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING, 2. DYNAMIC CNG TRADING 3. SANDUGO PRESS MARKETING AND SUPPLIES sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 01 March 2024. During the opening of the bid proposal and upon checking of the documentary requirements, DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING, DYNAMIC CNG TRADING, RFK GENERAL MERCHANDISE, SANDUGO PRESS MARKETING AND SUPPLIES and THEIA OFFICE SUPPLIES AND EQUIPMENT TRADING were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **DYNAMIC CNG TRADING** has been found to be "**Responsive**";

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **DYNAMIC CNG TRADING** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

**NOW, THEREFORE, We,** the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **DYNAMIC CNG TRADING** as the Lowest Calculated and Responsive Bidder with a bid amounting to **THREE HUNDRED SEVENTY-FIVE THOUSAND SEVEN HUNDRED FORTY-FOUR PESOS AND 75/100 ONLY (Php 375,744.75)** for the procurement of office and training supplies for May to December 2024 under Regular Program;
- (b) Recommend Alternative Mode of Procurement through Shopping as provided in Sec. 53.9 (b) and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 OIC Center Director the foregoing findings/recommendations.
