CONTRACT AGREEMENT

 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Two Hundred Eighteen Thousand Four Hundred Fifty Pesos Only (Php 218,450.00)** or such other sums as may be ascertained, **Panda Tea Garden Suites** agrees to **PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE TECHNOLOGY FORUM AND ASSESSMENT WORKSHOP FOR LOCAL FARMER TECHNICIANS (LFTS)** in accordance with his/her/its Bid.
 - 4. The **Agricultural Training Institute Regional Training Center VII** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
