

CONTRACT AGREEMENT

THIS AGREEMENT, made this 9th of May **2024** between **Agricultural Training Institute - Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called "the Entity") of the one part and **Carcar Eco Farm Resort Inc.** of Liburon Carcar City, Cebu, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF FOOD, ACCOMMODATION AND VENUE FOR THE DIGITAL FARMERS PROGRAM (DFP) FARM CONNECT** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Forty-Four Thousand One Hundred Pesos Only (Php 144,100.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Forty-Four Thousand One Hundred Pesos Only (Php 144,100.00)** or such other sums as may be ascertained, **Carcar Eco Farm Resort Inc.** agrees to **PROVISION OF FOOD, ACCOMMODATION AND VENUE FOR THE DIGITAL FARMERS PROGRAM (DFP) FARM CONNECT** in accordance with his/her/its Bid.
4. The **Agricultural Training Institute - Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

AFFIDAVIT

I, GEMMALYN VERANO, of legal age, Filipino, and residing at Carcar City, Cebu, after having been duly sworn in accordance with law, do hereby depose and state that:

- 1. I am the authorized representative of Carcar Eco Farm Resort Inc. with office address at Liburon Carcar City, Cebu;
2. As the authorized representative of Carcar Eco Farm Resort Inc., I have full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract for PROVISION OF FOOD, ACCOMMODATION AND VENUE FOR THE DIGITAL FARMERS PROGRAM (DFP) FARM CONNECT of the Agricultural Training Institute - Regional Training Center VII, as shown in the attached duly notarized Special Power of Attorney;
3. Carcar Eco Farm Resort Inc. is not "blacklisted" or barred from bidding by the Government of the Philippines or any of its agencies, offices, corporations, or Local Government Units, foreign government/foreign or international financing institution whose blacklisting rules have been recognized by the Government Procurement Policy Board, by itself or by relation, membership, association, affiliation, or controlling interest with another blacklisted person or entity as defined and provided for in the Uniform Guidelines on Blacklisting;
4. Each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct;
