**BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF TABANG TROPHY CENTER AND GENERAL MERCHANDISE AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY TOTE BAG FOR THE COCO CONVERGENCE OF STAKEHOLDERS THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)**

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, ATI- RTC 7 requested quotation for the procurement of advocacy tote bag for the Coco Convergence of Stakeholders in the amount allocation of **ONE HUNDRED SEVENTY-FIVE THOUSAND PESOS ONLY (P 175,000.00)**, dated June 14, 2024 under PR No. 2024-06-539;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on June 14, 2024 under PhilGEPS Ref.No. **10964316**, and ATI 7 website;

**WHEREAS**, in response to the said posting, 1. D.E. LINENS AND TEXTILE, 2. JOANNA’S LABORATORY, 3. TABANG TROPHY CENTER AND GENERAL MERCHANDISE sent their quotations through its BAC Secretariat;

**WHEREAS**, the Bid Opening was held on 25 June 2024. During the opening of the bid proposal and upon checking of the documentary requirements, D.E. LINENS AND TEXTILE, JOANNA’S LABORATORY and TABANG TROPHY CENTER AND GENERAL MERCHANDISE were declared “**eligible**” to participate in the bidding and thus rated as “**passed**” presented as follows:

**WHEREAS**, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **TABANG TROPHY CENTER AND GENERAL MERCHANDISE** has been found to be “**Responsive**”;

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **TABANG TROPHY CENTER AND GENERAL MERCHANDISE** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

**NOW, THEREFORE, We**, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:


- (a) Declare the **TABANG TROPHY CENTER AND GENERAL MERCHANDISE** as the Lowest Calculated and Responsive Bidder with a bid amounting to **NINEYT-FIVE THOUSAND NINE HUNDRED PESOS ONLY (Php 95,900.00)** for the procurement of advocacy tote bag for the Coco Convergence of Stakeholders;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
