

CONTRACT AGREEMENT

THIS AGREEMENT, made this ___ of 21 AUG 2024 2024 between **Agricultural Training Institute - Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called "the Entity") of the one part and **Thinking Tools Incorporated** of Island City Mall, Bustrillos St., Dampas, Tagbilaran City, Bohol, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly:

1. **PROCUREMENT OF LAPTOPS FOR PROCESSING AND PREPARATION OF REPORT (ACCOUNTANT AND COA USE)** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **Eighty-One Thousand Eight Hundred Eighty Pesos Only (Php 81,880.00)** (hereinafter called "the Contract Price").
2. **PROCUREMENT OF LCD PROJECTOR FOR THE TRAINING AND OTHER AF ACTIVITIES** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **Ninety-Six Thousand Pesos Only (Php 96,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Seventy-Seven Thousand Eight Hundred Eighty Pesos Only (Php 177,880.00)** or such other sums as may be ascertained, **Thinking Tools Incorporated** agrees to **PROCUREMENT OF LAPTOPS FOR PROCESSING AND PREPARATION OF REPORT (ACCOUNTANT AND COA USE) AND LCD PROJECTOR FOR**

4. The **Agricultural Training Institute – Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
