  - (b) BAC Resolution;
  - (c) Notice of Award of Contract and the Bidder's conforme thereto;
  - (d) Notice to Proceed;
  - (e) Contract documents that may be required by existing laws and/or the Procuring Entity.
- 3. In consideration of the payments to be made by the Procuring Entity to the Provider/Supplier as hereinafter mentioned, the Provider/Supplier hereby covenants with the Procuring Entity to execute and complete the Works/Services in conformity with the provisions of this Contract in all respects.
- 4. The Procuring Entity hereby covenants to pay the Provider/Supplier in consideration of the execution and completion of the Works/Services wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
