

# CONTRACT AGREEMENT

**AGREEMENT**, made this      of      JUN 05 2024      **2024** between **Agricultural Training Institute - Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines represented by **GRACIA F. ARADO, PhD** (hereinafter called "the Entity") of the one part and **NEW HOPE PRECISION AGRICULTURE CORPORATION** of Purok 39, Lomicad Compound, Barangay Ma-a, Talomo District, Davao City, represented by **ANTHONY TAN** (hereinafter called "Provider/Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **DRONE SERVICES AND FERTILIZER INPUTS with inclusions: Drone Fertilizer Broadcasting of up to 40kilos per flight with a minimum of 10 hectares per dispatch and Fertilizer Input - Urea 46-0-0 Application for 6 hectare with 12 bags x 50 kilo bags with delivery included and raw footage** hereinafter called "Drone Services and Fertilizer Inputs (the works/Services);

WHEREAS, the Provider/Supplier has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **Eighty Two Thousand Pesos (Php 82,000.00)** (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) Eligibility requirements, documents and/or statements (Quotation Certification, Mayor's Permit, SEC Certificate of Incorporation, BIR Certificate of Registration and PhilGeps Certificate of Registration);
  - (b) BAC Resolution;
  - (c) Notice of Award of Contract and the Bidder's conforme thereto;
  - (d) Notice to Proceed;
  - (e) Contract documents that may be required by existing laws and/or the Procuring Entity.
3. In consideration of the payments to be made by the Procuring Entity to the Provider/Supplier as hereinafter mentioned, the Provider/Supplier hereby covenants with the Procuring Entity to execute and complete the Works/Services in conformity with the provisions of this Contract in all respects.
4. The Procuring Entity hereby covenants to pay the Provider/Supplier in consideration of the execution and completion of the Works/Services wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
