

CONTRACT AGREEMENT

THIS AGREEMENT, made this ___ of JUN 20 2024 2024 between **Agricultural Training Institute - Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called "the Entity") of the one part and **WELLDONE EATERY** of Carbon Market, Cebu City, Cebu, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF CATERING SERVICES FOR THE BASIC DAIRY HUSBANDRY FOR CATTLE (MODULE 7-13) (CEBU)** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **Ninety-Seven Thousand Five Hundred Pesos Only (Php 97,500.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Ninety-Seven Thousand Five Hundred Pesos Only (Php 97,500.00)** or such other sums as may be ascertained, **WELLDONE EATERY** agrees to **PROVISION OF CATERING SERVICES FOR THE BASIC DAIRY HUSBANDRY FOR CATTLE (MODULE 7-13) (CEBU)** in accordance with his/her/its Bid.

4. The **Agricultural Training Institute - Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

AFFIDAVIT

I, JUDE CALOGERO S. GALLETTO, of legal age, Filipino, and residing at Liloan, Cebu, after having been duly sworn in accordance with law, do hereby depose and state that:

- 1. I am the sole proprietor or authorized representative of WELLDONE EATERY with office address at Carbon Market, Cebu City, Cebu;
2. As the owner and sole proprietor, or authorized representative of WELLDONE EATERY, I have full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract for PROVISION OF CATERING SERVICES FOR THE BASIC DAIRY HUSBANDRY FOR CATTLE (MODULE 7-13) (CEBU) of the Agricultural Training Institute - Regional Training Center VII, as shown in the attached duly notarized Special Power of Attorney;
3. WELLDONE EATERY is not "blacklisted" or barred from bidding by the Government of the Philippines or any of its agencies, offices, corporations, or Local Government Units, foreign government/foreign or international financing institution whose blacklisting rules have been recognized by the Government Procurement Policy Board, by itself or by relation, membership, association, affiliation, or controlling interest with another blacklisted person or entity as defined and provided for in the Uniform Guidelines on Blacklisting;
4. Each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct;

8. WELLDONE EATERY is aware of and has undertaken the following responsibilities as a Bidder:
a) Carefully examine all the Supporting Documents;
b) Acknowledging all conditions, local or otherwise, affecting the implementation of the Contract;
c) Making an estimate of the facilities available and needed for the contract to be bid, if any; and
d) Inquiring or securing Supplemental/Bid Bulletin(s) issued for PROVISION OF CATERING SERVICES FOR THE BASIC DAIRY HUSBANDRY FOR CATTLE (MODULE 7-13) (CEBU).
9. WELLDONE EATERY did not give or pay directly or indirectly, any commission, amount, fee, or any form of consideration, pecuniary or otherwise, to any person or official, personnel or representative of the government in relation to any procurement project or activity.
