BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF SEAWEED INTERNATIONAL EXPORTS INCORPORATED AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY TSHIRT AND POLOSHIRT FOR THE ADVOCACY MATERIALS FOR 2ND SEM 2024 TRAININGS UNDER FUND 01 THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of advocacy tshirt and poloshirt for the advocacy materials for 2nd Sem 2024 Trainings under Fund 01 in the amount allocation of **THREE HUNDRED TWELVE THOUSAND PESOS ONLY (P 312,000.00)**, dated June 19, 2024 under PR No. 2024-06-562;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on June 22, 2024 under PhilGEPS Ref.No. **10977863**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. ASHAS ENTERPRISE, 2. AVECILLA TRADING, 3. DMG CUSTOM APPAREL HUB, 4. ITRADE PRINTSHOPPE, 5. SEAWEED INTERNATIONAL EXPORTS INCORPORATED sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 27 June 2024. During the opening of the bid proposal and upon checking of the documentary requirements, ASHAS ENTERPRISE, AVECILLA TRADING, DMG CUSTOM APPAREL HUB, ITRADE PRINTSHOPPE and SEAWEED INTERNATIONAL EXPORTS INCORPORATED were declared "**eligible**" to participate in the bidding and thus rated as "**passed**" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by SEAWEED INTERNATIONAL EXPORTS INCORPORATED has been found to be "Responsive";

- (a) Declare the **SEAWEED INTERNATIONAL EXPORTS INCORPORATED** as the Lowest Calculated and Responsive Bidder with a bid amounting to **TWO HUNDRED EIGHTY-ONE THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (Php 281,460.00)** for the procurement of advocacy tshirt and poloshirt for the advocacy materials for 2nd Sem 2024 Trainings under Fund 01:
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
