BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF INNOVATION PRINTSHOPPE INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF PRINTING AND PUBLICATION OF LIVESTOCK TECHNOLOGY KIT AND DESK CALENDAR 2025 FOR THE REPRODUCTION & DISSEMINATION OF LIVESTOCK INFORMATION, EDUCATION, & COMMUNICATION (IEC) MATERIALS THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (*Section 53.9 of the 2016 Revised IRR of RA 9184*)

WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the provision of printing and publication of Livestock Technology Kit and Desk Calendar 2025 for the Reproduction & Dissemination of Livestock Information, Education, & Communication (IEC) Materials in the amount allocation of **TWO HUNDRED TWENTY-NINE THOUSAND FIVE HUNDRED PESOS ONLY (P 229,500.00)**, dated June 21, 2024 under PR No. 2024-06-570;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on June 22, 2024 under PhilGEPS Ref.No. **10977995**, and ATI 7 website

WHEREAS, in response to the said posting, 1. AG3 COLORS PRINTING PRESS, 2. ERZALAN PRINTING PRESS, 3. INNOVATION PRINTSHOPPE INC., 4. OPTIMA TYPOGRAPHICS sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 27 June 2024. During the opening of the bid proposal and upon checking of the documentary requirements, ERZALAN PRINTING PRESS, INNOVATION PRINTSHOPPE INC. and OPTIMA TYPOGRAPHICS were declared “**eligible**” to participate in the bidding and thus rated as “**passed**” while AG3 COLORS PRINTING PRESS was “disqualified”;

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **INNOVATION PRINTSHOPPE INC.** has been found to be “**Responsive**”;

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **INNOVATION PRINTSHOPPE INC.** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **INNOVATION PRINTSHOPPE INC.** as the Lowest Calculated and Responsive Bidder with a bid amounting to **ONE HUNDRED TWENTY-SEVEN THOUSAND TWENTY-FIVE PESOS ONLY (Php 127,025.00)** for the provision of printing and publication of Livestock Technology Kit and Desk Calendar 2025 for the Reproduction & Dissemination of Livestock Information, Education, & Communication (IEC) Materials;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.


