BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF CEBOOM ENTERPRISES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY TSHIRT AND POLOSHIRT FOR THE ADVOCACY MATERIALS FOR 2ND SEM 2024 TRAININGS UNDER FUND 07 CFITF THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of advocacy tshirt and poloshirt for the advocacy materials for 2nd Sem 2024 Trainings under Fund 07 CFITF in the amount allocation of **FIVE HUNDRED SEVENTY-FIVE THOUSAND TWO HUNDRED FIFTY PESOS ONLY (P 575,250.00)**, dated June 19, 2024 under PR No. 2024-06-561;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on June 22, 2024 under PhilGEPS Ref.No. **10977790**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. ASHAS ENTERPRISE, 2. AVECILLA TRADING, 3. CEBOOM ENTERPRISES, 4. DMG CUSTOM APPAREL HUB, 5. ITRADE PRINTSHOPPE, 6. SEAWEED INTERNATIONAL EXPORTS INCORPORATED sent their quotations through its BAC Secretariat:

WHEREAS, the Bid Opening was held on 27 June 2024. During the opening of the bid proposal and upon checking of the documentary requirements, ASHAS ENTERPRISE, AVECILLA TRADING, CEBOOM ENTERPRISES, DMG CUSTOM APPAREL HUB, ITRADE PRINTSHOPPE and SEAWEED INTERNATIONAL EXPORTS INCORPORATED were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **CEBOOM ENTERPRISES** has been found to be "**Responsive**";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **CEBOOM ENTERPRISES** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **CEBOOM ENTERPRISES** as the Lowest Calculated and Responsive Bidder with a bid amounting to **THREE HUNDRED EIGHTY-SEVEN THOUSAND THREE HUNDRED FIFTY PESOS ONLY (Php 387,350.00)** for the procurement of advocacy tshirt and poloshirt for the advocacy materials for 2nd Sem 2024 Trainings under Fund 07 CFITF;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
