BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF THINKING TOOLS INCORPORATED AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF LCD PROJECTOR FOR THE TRAINING AND OTHER AF ACTIVITIES THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of LCD Projector for the Training and other AF Activities in the amount allocation of **ONE HUNDRED FIVE THOUSAND PESOS ONLY (P 105,000.00)**, dated August 2, 2024 under PR No. 2024-08-717;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on July 8, 2024 under PhilGEPS Ref.No. **11123731**, and ATI 7 website;

**WHEREAS**, in response to the said posting, 1. BUSINESS MACHINE CORPORATION, 2. THINKING TOOLS INCORPORATED sent their quotations through its BAC Secretariat;

**WHEREAS**, the Bid Opening was held on 14 August 2024. During the opening of the bid proposal and upon checking of the documentary requirements, BUSINESS MACHINE CORPORATION, 2. THINKING TOOLS INCORPORATED were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval the Center Director the foregoing findings/recommendations.
