## CONTRACT AGREEMENT

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE TOT ON FARM BUSINESS SCHOOL (BATCH 1)** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Ninety-Six Thousand Pesos Only (Php 496,000.00)** (hereinafter called "the Contract Price").

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
    - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
  - 3. In consideration for the sum of Four Hundred Ninety-Six Thousand Pesos Only (Php 496,000.00) or such other sums as may be ascertained, Pacheco's Inn agrees to PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE TOT ON FARM BUSINESS SCHOOL (BATCH 1) in accordance with his/her/its Bid.
  - 4. The **Agricultural Training Institute Regional Training Center VII** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
