CONTRACT AGREEMENT

- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Two Hundred Eighty-Eight Thousand Pesos Only (Php 288,000.00) or such other sums as may be ascertained, Panda Tea Garden Suites agrees to PROVISION OF FOOD AND ACCOMMODATION FOR THE COACHING AND CRITIQUING OF THE MUNICIPAL AGRICULTURE AND FISHERIES MODERNIZATION DEVELOPMENT PLAN FY 2025-2030 FOR THE LGUS OF BOHOL in accordance with his/her/its Bid.
- 4. The **Agricultural Training Institute Regional Training Center VII** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
