The **DEPARTMENT OF AGRICULTURE (DA)**, through the **AGRICULTURAL TRAINING INSTITUTE – REGIONAL TRAINING CENTER 7 (ATI-RTC 7)**, with official address at Cabawan District, Tagbilaran City, Bohol, herein represented by its Center Director **Dr. GRACIA F. ARADO**, hereinafter, the "**ATI RTC-7**"

-and

The NATIONAL MEAT INSPECTION SERVICE RTOC 7, a Philippine Government agency, with office address at Maguikay, Mandaue City, Cebu, duly represented herein by its Director, DR. ALVIN A. LEAL, hereinafter, the "NMIS RTOC 7"

WITNESSETH:

WHEREAS, the **ATI RTC-7**, has resorted to *Negotiated Procurement* under Section 53.5 (Agency-to-Agency) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 otherwise known as the Government Procurement Reform Act;

WHEREAS, the **ATI RTC-7**, will be conducting a Basic Meat Inspection Training Course on August 5-30, 2024, where estimated of 20 participants and 2 training management team (TMT).

WHEREAS, the NMIS RTOC 7, has a facility to accommodate the said training.

WHEREAS, upon the request of the **ATI RTC-7**, the **NMIS RTOC 7**, has agreed to provide the venue and accommodation for the aforementioned training.

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual covenants, stipulations and agreements, the Parties have agreed, as they do hereby agree as follows:

ARTICLE I OBILGATIONS OF THE ATI RTC-7

- 1.1 The ATI RTC-7 shall pay the NMIS RTOC 7 the amount of EIGHTY-TWO THOUSAND FIVE HUNDRED PESOS ONLY (Php 82,500.00) for the venue rental and accommodation following the schedules indicated in Article III of this Agreement.
- 1.2 The **ATI RTC-7** shall inform the **NMIS RTOC 7** of any special arrangement with the outside entity done outside the terms and conditions of this agreement.

ARTICLE II OBILGATIONS OF THE NMIS RTOC 7

- 2.1 The **NMIS RTOC 7** shall provide the venue and accommodation for the Basic Meat Inspection Training Course with the following features and amenities:
 - 2.1.1. Capacity to accommodate a maximum of 22 persons;
 - 2.1.2. Adequate and clean comfort rooms for the male and female employees;



- 2.1.3. Engineering and janitorial services;
- 2.1.4. Fully air-conditioned venue on the day of the training August 5-30, 2024/8am to 5pm;
- 2.1.5. Should provide sound system during the training;
- 2.1.6. Availability of drinking water 24/7 in the facility;
- 2.1.6. Availability of venue on August 5-30,2024;
- 2.1.7. Maximum of 15 persons per room; and
- 2.1.8. Clean and full airconditioned room with complete amenities.

ARTICLE III TERMS OF PAYMENT

Payment for the services shall be made on the following schedule:

- Payment for the service in the amount of EIGHTY-TWO THOUSAND FIVE HUNDRED PESOS ONLY (Php 82,500.00) shall be made one (1) to two (2) months after receipt of the Statement of Account.
- All payments shall be subject to existing ATI RTC-7 rules and regulations. 3.2.

ARTICLE IV **EFFECTIVITY**

- This agreement shall take effect immediately upon signing thereof by both parties.
- This agreement may be pre-terminated for breach of any of the provisions herein or any 4.1. valid and justifiable reason by giving the other party a written notice.

ARTICLE V MISCELLANEOUS PROVISIONS

- The parties are independent entities and no agency, partnership, joint venture, employment or formal business organization of any kind is created by this Agreement and neither party shall 5.1. have the authority to represent the other.
- The NMIS RTOC 7 shall not use or disclose to any person, firm or corporation any information concerning the affairs of the ATI RTC-7, which she may have acquired in the course of or as an incident to this Agreement for its own benefit to the detriment of the ATI RTC-7.
- No party shall be held liable to the other for any delay or non-performance of its obligations under this Agreement arising from any cause or causes beyond its reasonable control but not limited to acts of God, government acts under its police, power, war, terrorist attack, fire, flood, explosion or civil commotion.
