BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF GOLDEN PRINCE HOTEL & SUITES AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE TRAINING ON THE SITE SUITABILITY MAPPING FOR COLD STORAGE FACILITIES FOR SELECTED AGRI-FISHERY PRODUCTS USING GEOGRAPHIC INFORMATION SYSTEM AND ANALYTICAL HIERARCHY PROCESS THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 36 and Section 53.9 of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS, Section 36.** A Single Calculated and Responsive Bid (SCRB) or a Single Rated and Responsive Bid (SRRB) shall be considered for award if it falls under any of the following circumstances:

- a) If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;
- b) If after advertisement, more than one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or
- c) If after the eligibility check, more than one bidder meets the eligibility requirements, but only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

In all instances, the Procuring Entity shall ensure that the ABC reflects the most advantageous prevailing price for the Government.

WHEREAS, ATI- RTC 7 requested quotation for the provision of food, accommodation and venue rental for the Training on the Site Suitability Mapping for Cold Storage Facilities for selected Agri-Fishery Products using Geographic Information System and Analytical Hierarchy Process in the amount allocation of **Two Hundred Sixty-Seven Thousand Nine Hundred Pesos Only (P 267,900.00)**, dated June 21, 2024 under PR No. 2024-06-583;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on June 25, 2024 under PhilGEPS Ref.No. **10983332** and ATI 7 website;

**WHEREAS**, in response to the said posting, **GOLDEN PRINCE HOTEL & SUITES** sent their quotation through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 03 July 2024. During the opening of the bid proposal and upon checking of the documentary requirements, GOLDEN PRINCE HOTEL & SUITES was declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by GOLDEN PRINCE HOTEL & SUITES has been found to be "Responsive";

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **GOLDEN PRINCE HOTEL & SUITES** as the Single Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

**NOW, THEREFORE, We,** the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **GOLDEN PRINCE HOTEL & SUITES** as the Single Calculated and Responsive Bidder with a bid amounting to **Two Hundred Sixty-Five Thousand Eighty Pesos Only (Php 265,080.00)** for the provision of food, accommodation and venue rental for the Training on the Site Suitability Mapping for Cold Storage Facilities for selected Agri-Fishery Products using Geographic Information System and Analytical Hierarchy Process;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
