BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF GOLDEN PRINCE HOTEL AND SUITES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF FOOD AND ACCOMMODATION FOR THE CHARTING DIRECTIONS TOWARDS RESULTS-BASED INTERVENTIONS: TECHNICAL REVIEW AND PLANNING WORKSHOPS FOR FISCAL YEAR (FY 2026) PLANS AND BUDGET PROPOSALS THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the provision of food and accommodation for the Charting Directions towards Results-Based Interventions: Technical Review and Planning Workshops for Fiscal Year (FY 2026) Plans and Budget Proposals in the amount allocation of Three Hundred Twenty-eight Thousand Nine Hundred Fifty Pesos Only (P 328,950.00), dated September 16, 2024 under PR No. 2024-09-806;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on September 17, 2024 under PhilGEPS Ref. No. **11255981** and ATI 7 website;

WHEREAS, in response to the said posting, CEBU BUSINESS HOTEL and GOLDEN PRINCE HOTEL INC., sent their quotations through the BAC Secretariat;

WHEREAS, the Bid Opening was held on 23 September 2024. During the opening of the bid proposal and upon checking of the documentary requirements, CEBU BUSINESS HOTEL AND GOLDEN PRINCE HOTEL INC. were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations and conducted site validation as per requirement by the End-user. The bid proposals submitted by the bidders has been found to be "Unresponsive" (see attached post-qualification evaluation report);

WHEREAS, the BAC thru its TWG evaluated the bid proposals by the GOLDEN PRINCE HOTEL INC. as the second Lowest Calculated Bid during the bid opening was then post-evaluated. The BAC-TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations and conducted site validation as per requirement by the End-user. The bid proposals submitted by the bidders has been found to be "Responsive"

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared GOLDEN PRINCE HOTEL INC. as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the GOLDEN PRINCE HOTEL INC. as the Single Calculated and Responsive Bidder with a bid amounting to Three Hundred Twenty Thousand Three Hundred Fifty Pesos Only (Php 320,350.00) for the provision of food and accommodation for the Charting Directions towards Results-Based Interventions: Technical Review and Planning Workshops for Fiscal Year (FY 2026) Plans and Budget Proposals;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
