

THIS AGREEMENT, made this 27th of September 2024 between **Agricultural Training Institute – Regional Training Center VII** of Cabawan District, Tagbilaran City, Philippines (hereinafter called “the Entity”) of the one part and **Amparitas Integrated Farm** of Tagasaka, Hinatuan, Surigao Del Sur, Philippines (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF FOOD AND ACCOMMODATION FOR THE COMMUNITY LINK: ADOPT A FCA PROJECT LEARNING JOURNEY** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Forty-Seven Thousand Pesos Only (Php 147,000.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Notice of Award of Contract; and the Bidder’s conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Forty-Seven Thousand Pesos Only (Php 147,000.00)** or such other sums as may be ascertained, **Amparitas Integrated Farm** agrees to **PROVISION OF FOOD AND ACCOMMODATION FOR THE COMMUNITY LINK: ADOPT A FCA PROJECT LEARNING JOURNEY** in accordance with his/her/its Bid

4. The **Agricultural Training Institute – Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

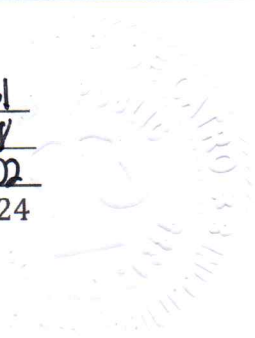



AFFIDAVIT

I, APRIL ROSE A. DUERO of legal age, married, Filipino, and residing at Hinatuan, Surigao del Sur after having been duly sworn in accordance with law, do hereby depose and state that:

1. I am the authorized representative of AMPARITAS INTEGRATED FARM with office address at Tagasaka, Hinatuan, Surigao del Sur;
2. As the authorized representative of AMPARITAS INTEGRATED FARM, I have full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract for the **Provision of food and venue for the conduct of Community Link: Adopt a FCA Project Learning Journey on September 29-October 1, 2024** as shown in the attached duly notarized Special Power of Attorney;
3. AMPARITAS INTEGRATED FARM is not "blacklisted" or barred from bidding by the Government of the Philippines or any of its agencies, offices, corporations, or Local Government Units, foreign government/foreign or international financing institution whose blacklisting rules have been recognized by the Government Procurement Policy Board, by itself or by relation, membership, association, affiliation, or controlling interest with another blacklisted person or entity as defined and provided for in the Uniform Guideline on Blacklisting;
4. Each document submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct;
5. AMPARITAS INTEGRATED FARM is authorizing the Head of the Procuring Entity or its duly authorized representative(s) to verify all the documents submitted;
6. [If a sole proprietorship:] The owner or sole proprietor is not related to the Head of the Procuring Entity, members of the Bids and Awards Committee (BAC), the Technical Working Group, and the BAC Secretariat, the head of the Project Management Office or the end-user unit, and the project consultants by consanguinity or affinity up to the third civil degree;
7. AMPARITAS INTEGRATED FARM complies with existing labor laws and standards; and
8. AMPARITAS INTEGRATED FARM is aware of and has undertaken the responsibilities as a Bidder in compliance with the Philippine Bidding Documents, which includes:
 - a. Carefully examining all of the Bidding Documents;



- b. Acknowledging all conditions, local or otherwise, affecting the implementation of the Contract;
 - c. Making an estimate of the facilities available needed for the contract to be bid, if any; and
 - d. Inquiring or securing Supplemental/Bid Bulletin(s) issued for the PROJECT.
9. AMPARITAS INTEGRATED FARM did not give or pay directly or indirectly, any commission, amount, fee, or any form of consideration, pecuniary or otherwise, to any person or official, personnel or representatives of the government in relation to any procurement project or activity.

Incase advance payment was made or given, failure to perform or deliver any of the obligation and undertakings in the contract shall be sufficient grounds to constitute criminal liability for Swindling(Estafa) or the commission of fraud with unfaithfulness or abuse of confidence through misappropriating or converting any payments received by a person or entity under an obligation involving the duty to deliver certain goods or services, to the prejudice of the public and the government of the Philippines pursuant to Article 315 of Act No. 3815 s. 1930, as amended, or the Revised Penal Code.
