CONTRACT AGREEMENT

THIS AGREEMENT, made this Month of September 2024 between Agricultural Training Institute – Regional Training Center VII of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called "the Entity") of the one part and RAF & NATS KAN-ANAN SUGBAHAN of Balayong, Pamplona, Negros Oriental, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE SEASON LONG TRAINING ON COCONUT FARM BUSINESS SCHOOL (NEG OR) and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of Three Hundred Eighty-One Thousand Two Hundred Fifty Pesos Only (Php 381,250.00) (hereinafter called "the Contract Price").

 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Three Hundred Eighty-One Thousand Two Hundred Fifty Pesos Only (Php 381,250.00) or such other sums as may be ascertained, RAF & NATS KAN-ANAN SUGBAHAN agrees to PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE SEASON LONG TRAINING ON COCONUT FARM BUSINESS SCHOOL (NEG OR) in accordance with his/her/its Bid.
- 4. The **Agricultural Training Institute Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
