WHEREAS, in response to the said posting, BOHOL APC MULTIPURPOSE COOPERATIVE sent their quotation through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 05 November 2024. During the opening of the bid proposal and upon checking of the documentary requirements, BOHOL APC MULTIPURPOSE COOPERATIVE was declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

It was found out by the TWG that the bid proposal submitted by BOHOL APC MULTIPURPOSE COOPERATIVE has been found to be "Responsive";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared BOHOL APC MULTIPURPOSE COOPERATIVE as the Single Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

**NOW, THEREFORE, We,** the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the BOHOL APC MULTIPURPOSE COOPERATIVE as the Single Calculated and Responsive Bidder with a bid amounting to One Hundred Thirty-Five Thousand Pesos Only (Php 135,000.00) for the provision of catering services for the Training on Coconut Production and Management;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the abovecited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.

### A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHOD OF PROCUREMENT - DIRECT CONTRACTING AND AWARD

Section 50 and Annex "H" A of 2016 Revised IRR of RA 9184

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity(H (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, Section 58, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of R.A 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, Section 50 provides further that Direct Contracting or single source procurement is a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the condition of sale. Direct Contracting maybe resorted under any of the following conditions:

- a) Procurement of Good of proprietary nature which can be obtained only from proprietary source, i.e. when patents, trade secrets, and copyrights prohibits others from manufacturing the same item;
- When procurement of critical components from specific supplies is a condition precedent to hold a contractor to guarantee its project performance, in accordance to the provisions of its contract; or
- c) Those sold by an exclusive dealer of manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous term to the GoP.

WHEREAS, the Agricultural Training Institute − 7 Center Director/Head of Procuring Entity had approved Purchase Request (P.R.) No. 2024-10-864 to procure Toners for XEROX 7855 to be used for reproduction of training and office documents at CDMS office with an Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos Only (₱ 120,000.00) in accordance to the End-user' Project Procurement Management Plan (PPMP);
