BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF DYNAMIC CNG TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF A4 BONDPAPER AND C2S A3 PAPER FOR THE IEC REPRODUCTION AND DISSEMINATION THROUGH ALTERNATIVE MODE OF PROCUREMENT - SHOPPING (Section 52.1 (b) of the 2016 Revised IRR of RA 9184)

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of A4 bondpaper and C2S A3 paper for the IEC reproduction and dissemination in the amount allocation of SEVENTY-SEVEN THOUSAND NINE HUNDRED FIFTY PESOS ONLY (P 77,950.00), dated September 20, 2024 under PR No. 2024-09-824;

WHEREAS, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders September 24, 2024 under PhilGEPS Ref.No. **11282054**, and ATI 7 website, reposted under bid bulletin no. 11282054-01 and 11282054-02;

WHEREAS, in response to the said posting, 1. SANDUGO PRESS MARKETING AND SUPPLIES sent their quotations through its BAC Secretariat;

WHEREAS, the procurement team facilitated the invitation of potential bidders and sent 2 sets of Request for Quotation;

WHEREAS, in response to the said invitation, 1 DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING, 2. DYNAMIC CNG TRADING sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 11 October 2024. During the opening of the bid proposal and upon checking of the documentary requirements, DALIKYAT GENTRADE SUPPLIES AND DRY GOODS TRADING, DYNAMIC CNG TRADING and SANDUGO PRESS MARKETING AND SUPPLIES were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **DYNAMIC CNG TRADING** has been found to be "**Responsive**";

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG's recommendation and declared **DYNAMIC CNG TRADING** as the Lowest Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **DYNAMIC CNG TRADING** as the Lowest Calculated and Responsive Bidder with a bid amounting to **FORTY-SEVEN THOUSAND SEVEN HUNDRED NINETY-FOUR PESOS ONLY (Php 47,794.00)** for the procurement of A4 bondpaper and C2S A3 paper for the IEC reproduction and dissemination;
- (b) Recommend Alternative Mode of Procurement through Shopping as provided in Sec. 53.9 (b) and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 OIC Center Director the foregoing findings/recommendations.
