BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF TABANG TROPHY CENTER AND GENERAL MERCHANDISE AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF STRING BAG WITH PRINT FOR THE 2024 BALA CONGRESS THROUGH NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)

**WHEREAS**, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, ATI- RTC 7 requested quotation for the procurement of String Bag with print for the 2024 BALA Congress in the amount allocation of **ONE HUNDRED NINETY THOUSAND FIVE HUNDRED PESOS ONLY (P 190,500.00)**, dated October 11, 2024 under PR No. 2024-10-882:

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on October 16, 2024 under PhilGEPS Ref.No. **11361276**, and ATI 7 website;

WHEREAS, in response to the said posting, 1. CURIT SECURITY AND MILITARY SUPPLIES, 2. D.E. LINENS AND TEXTILE TRADING, 3. FELINES GIFT SHOP, 4. TABANG TROPHY CENTER AND GENERAL MERCHANDISE, 5. ZELT TAILORING sent their quotations through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 22 October 2024. During the opening of the bid proposal and upon checking of the documentary requirements, CURIT SECURITY AND MILITARY SUPPLIES, D.E. LINENS AND TEXTILE TRADING, FELINES GIFT SHOP, TABANG TROPHY CENTER AND GENERAL MERCHANDISE and ZELT TAILORING were declared "eligible" to participate in the bidding and thus rated as "passed" presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by TABANG TROPHY CENTER AND GENERAL MERCHANDISE has been found to be "Responsive";

**NOW, THEREFORE, We,** the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the TABANG TROPHY CENTER AND GENERAL MERCHANDISE as the Lowest Calculated and Responsive Bidder with a bid amounting to ONE HUNDRED TEN THOUSAND FOUR HUNDRED NINETY PESOS ONLY (Php 110,490.00) for the procurement of String Bag with print for the 2024 BALA Congress;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
