

CONTRACT AGREEMENT

THIS AGREEMENT, made this 24th of June 2024 between **Agricultural Training Institute – Regional Training Center VII** of Cabawan District, Tagbilaran City, Bohol, Philippines (hereinafter called “the Entity”) of the one part and **Lamac Multipurpose Cooperative** of Mohon, Colonia, Tuburan, Cebu, Philippines (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE BE AMAZED WITH BAMBOOING: GENDER-BASED CAPABILITY ENHANCEMENT TRAINING ON HVC TECHNOLOGIES/ TRAINING ON SUSTAINABLE BAMBOO PRODUCTION AND ENTERPRISE** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Sixty Thousand One Hundred Sixty Pesos Only (Php 160,160.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Notice of Award of Contract; and the Bidder’s conforme thereto; and
- iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Sixty Thousand One Hundred Sixty Pesos Only (Php 160,160.00)** or such other sums as may be ascertained, **Lamac Multipurpose Cooperative** agrees to **PROVISION OF FOOD, ACCOMMODATION AND VENUE RENTAL FOR THE BE AMAZED WITH BAMBOOING: GENDER-BASED CAPABILITY ENHANCEMENT TRAINING ON HVC TECHNOLOGIES/ TRAINING ON SUSTAINABLE BAMBOO PRODUCTION AND ENTERPRISE** in accordance with his/her/its Bid

4. The **Agricultural Training Institute – Regional Training Center VII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

AFFIDAVIT

I, MONETTE T. TUMULAK, of legal age, Filipino, and residing at Tuburan, Cebu, after having been duly sworn in accordance with law, do hereby depose and state that:

- 1. I am the duly authorized and designated representative of Lamac Multipurpose Cooperative with office address at Mohon, Colonia, Tuburan, Cebu;
2. 4. Each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct;

None of the officers and members of Lamac Multipurpose Cooperative is related to the Head of the Procuring Entity, Procurement Agent if engaged, members of the Bids and Awards Committee (BAC), the Technical Working Group, and the BAC Secretariat, the head of the Project Management Office or the end-user unit, and the project consultants by consanguinity or affinity up to the third civil degree;
