WHEREAS, the procurement team facilitated the invitation of potential bidders and sent 3 sets of Request for Quotation;

WHEREAS, in response to the said invitation, **MEDELLIN FOODHAUS & GRILL** sent their quotation through its BAC Secretariat;

WHEREAS, the Bid Opening was held on 28 March 2025. During the opening of the bid proposal and upon checking of the documentary requirements, **MEDELLIN FOODHAUS & GRILL** was declared “**eligible**” to participate in the bidding and thus rated as “**passed**” presented as follows:

WHEREAS, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **MEDELLIN FOODHAUS & GRILL** has been found to be “**Responsive**”;

WHEREAS, the BAC further evaluated the aforementioned bid proposal/ quotation and agreed to adopt the TWG’s recommendation and declared **MEDELLIN FOODHAUS & GRILL** as the Single Calculated and Responsive Bidder, and have agreed to recommend to the ATI Center Director that said bidder be awarded;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- Declare the **MEDELLIN FOODHAUS & GRILL** as the Single Calculated and Responsive Bidder with a bid amounting to **Ninety-Nine Thousand Seven Hundred Fifty Pesos Only (Php 99,750.00)** for the provision of catering services for the Nurturing Hope, Harvesting Joy: Vegetable Production Training for Differently-Abled Persons;
- Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
