**BAC RESOLUTION RECOMMENDING APPROVAL AND AWARD OF CEBOOM ENTERPRISES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF ADVOCACY POLOSHIRT AND ADVOCACY TSHIRT FOR THE 1ST SEM 2025 TRAININGS UNDER FUND 01 (O. ESSETS, RICE, CORN, LIVESTOCK, OA AND NUPAP THROUGH NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT AS ALTERNATIVE MODE OF PROCUREMENT (Section 53.9 of the 2016 Revised IRR of RA 9184)**

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, ATI- RTC 7 requested quotation for the procurement of advocacy poloshirt and advocacy tshirt for the 1st Sem 2025 Trainings under Fund 01 (O.Essets, Rice, Corn, Livestock, OA and NUPAP in the amount allocation of **NINE HUNDRED FIFTY-SEVEN THOUSAND FIFTY PESOS ONLY (P 957,050.00)**, dated February 10, 2025 under PR No. 2025-02-174;

**WHEREAS**, in accordance with RA 9184 and its Implementing Rules and Regulations, the abovementioned request was published to the Philippine Government Electronic Procurement System (PhilGEPS) for online registered bidders on February 13, 2025 under PhilGEPS Ref.No. **11757723**, and ATI 7 website;

**WHEREAS**, in response to the said posting, 1. AVECILLA TRADING, 2. CEBOOM ENTERPRISES, 3. ZHUJAR MANUFACTURING INCORPORATION sent their quotations through its BAC Secretariat;

**WHEREAS**, the Bid Opening was held on 18 February 2025. During the opening of the bid proposal and upon checking of the documentary requirements, AVECILLA TRADING, CEBOOM ENTERPRISES and ZHUJAR MANUFACTURING INCORPORATION were declared “**eligible**” to participate in the bidding and thus rated as “**passed**” presented as follows:

**WHEREAS**, the bid proposal/ quotation by the said bidders during the bid opening was then post-evaluated, the TWG conducted careful examination, validation and verification of all the eligibility, technical and financial requirements as required by Republic Act No. 9184 and its Implementing Rules and Regulations. It was found out by the TWG that the bid proposal submitted by **CEBOOM ENTERPRISES** has been found to be “**Responsive**”;

**NOW, THEREFORE, We**, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- (a) Declare the **CEBOOM ENTERPRISES** as the Lowest Calculated and Responsive Bidder with a bid amounting to **SIX HUNDRED EIGHTY-THREE THOUSAND NINE HUNDRED SIXTY PESOS ONLY (Php 683,960.00)** for the procurement of advocacy poloshirt and advocacy tshirt for the 1st Sem 2025 Trainings under Fund 01 (O.Essets, Rice, Corn, Livestock, OA and NUPAP;
- (b) Recommend Alternative Mode of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 for the above-cited goods/services; and
- (c) Recommend for approval by the ATI 7 Center Director the foregoing findings/recommendations.
