# VISION MISSION GOALS



Carood Watershed Model Forest (CWMF) program is a Convergence Initiative lead by the Department of Agriculture (DA), Department of Environment and Natural Resources (DENR), Department of Agrarian Reform (DAR) and Department of Interior and Local Government (DILG). The watershed is the 5th largest watershed in the Province of Bohol. It has an area of 25,405.79 hectares covering the Municipalities of Ubay, Alicia, Pilar, Mabini, Candijay, Guindulman, Anda, Duero, Sierra Bullones and San Miguel with a total of 73 barangays within the watershed. There are three (3) land classification; timberland with 7,192.02 hectares (28%), Alienable and Disposable-17,038.28 hectares (67%) and Military Reservation - 1,175.49 hectares (5%)

CWMF is the 52nd member of the International Model Forest Network (IMFN). IMFN is a non-government organization whose members and supporters work toward for the common goal of the sustainable management of forest-based landscapes, through the Model Forest on a flexible approach to landscape, and ecosystem management that combines the social, environmental and economic needs of local communities with the long-term sustainability of large landscapes in which forests is an important feature.

Carood Watershed Model Forest is managed by the Carood Watershed Model Forest Management Council, Incorporated (CWMFMC). CWMFMC is an inter-LGU, multi-agency, multi-sectoral consortium working to ensure effective and sustainable resource management with a holistic watershed approach while balancing the development needs of local communities.
