## INVITATION TO BID

The Agricultural Training Institute- Regional Training Center 8 (ATI-RTC 8), through the General Fund (F01); Coconut Farmers and Industry Trust Fund (F07) and Rice Enhancement Competitive Fund (F03) intends to apply the sum of Two Million Seven Hundred Sixteen Thousand Eight Hundred Fifty Pesos (Php 2,716,850.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Food Catering Services of ATI-RTC VIII Center-based Trainings/Activities for the 2<sup>nd</sup> semester of 2023/ Identification No. ATI-RTC8-ITB-2023-005 being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed, within *the last two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from Agricultural Training Institute-Regional Training Center 8 (ATI-RTC 8) Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below during 8:00am to 5:00pm, Monday to Friday except during holidays.
- A complete set of Bidding Documents may be acquired by interested Bidders on May 26, 2023, 8:00am to 5:00pm from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS ONLY(PHP 5,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, <a href="https://ati2.da.gov.ph/ati-8/content/bids">https://ati2.da.gov.ph/ati-8/content/bids</a> provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The Agricultural Training Institute- Regional Training Center 8 (ATI-RTC 8) will hold a Pre-Bid Conference on June 02, 2023, 10:00am at ATI-RTC 8 Training Hall, VSU Campus, Visca, Baybay City, Leyte, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before **June 15, 2023**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause **Error! Reference source not found.**

Bid opening shall be on June 15, 2023, Thursday, 10:00am at ATI-RTC 8 Training Hall, VSU Campus, Visca, Baybay City, Leyte. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
