DECLARATION OF FAILURE OF BIDDING FOR THE FOOD CATERING SERVICES, ACCOMMODATION, VENUE, MACHINE RENTAL AND TRANSPORT VEHICLE RENTAL FOR THE CONDUCT OF TRAINING OF TRAINERS ON THE PRODUCTION OF HIGH-QUALITY INBRED RICE AND SEEDS AND FARM MECHANIZATION, 2 BATCHES

BAC Resolution No. 19, s. 2024

WHEREAS, The Agricultural Training Institute Regional Training Center 8 posted the Invitation to Bid for the aforementioned Project with **Approved Budget for Contract (ABC) in the Amount of One Million One Hundred Ninety-Eight Thousand Seven Hundred Eighty Pesos Pesos (Php 1,198,780.00)** in PhilGEPS website (PhilGEPS Ref. No. 10514260) and the ATI Website and other conspicuous places in Baybay City, Leyte.

WHEREAS, in response to the said posting, only **ALDE TECHNICAL VOCATIONAL SCHOOL AND SERVICES INC** bought the bidding documents from the BAC Secretariat.

WHEREAS, during the scheduled submission and opening of bids on February 21, 2024, only **ALDE TECHNICAL VOCATIONAL SCHOOL AND SERVICES INC**. submitted the bid proposal.

WHEREAS, under Section 35.1 (c) of the IRR of RA 9184, the BAC shall declare the bidding a failure, when all bids fail to comply with all the bid requirements, or fail post-qualification, or in the case of consulting services, there is no successful negotiations. Hence the bidder failed to present the Valid Philgeps Registration Certificate (Platinum Membership).

WHEREAS, Section 35.2 of the same Act provides that in order to determine the reason of the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

WHEREAS, Section 35.3 of the same Act provides that the BAC shall conduct a re-bidding with re-advertisement and/or reposting, as provided for in Section 21.2 of the IRR;

NOW THEREFORE, We, the members of the Bids and Awards Committee, by the virtue of the powers vested on us by law, hereby **RESOLVE** to declare a failure of bidding for the Food Catering Services, Accommodation, Venue, Machine Rental And Transport Vehicle Rental for The Conduct of Training of Trainers on The Production of High-Quality Inbred Rice And Seeds And Farm Mechanization, 2 Batches.
