



**A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SECURITY SERVICES FOR ATI-RTC 8 & 4-H LEARNING HUB FOR THE PERIOD OF FEBRUARY 1, 2024 – JANUARY 31, 2025**

**BAC Resolution No. 03, s. 2024**

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” Created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

**WHEREAS**, Section 10 Rule IV of the IRR-A of the RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

**WHEREAS**, The Agricultural Training Institute Regional Training Center 8 posted the Invitation to Bid for the aforementioned Project with **Approved Budget for Contract (ABC) in the Amount of One Million Two Hundred Thirty Thousand Pesos (Php 1,230,000.00)** in PhilGEPS website (PhilGEPS Ref. No. 10428106) and the ATI Website and other conspicuous places in Baybay City, Leyte.

**WHEREAS**, in response to the said posting, only **VISION SECURITY SERVICES, INC.** bought the bidding documents from the BAC Secretariat.

**WHEREAS**, during the Bid Opening held on January 09, 2024, only one (1) bidder, **VISION SECURITY SERVICES INC.** submitted the bid proposal timely, and upon strict scrutiny and examination, it was found out that the prospective bidder qualified and complied based on the standards set forth; and was declared as the **SINGLE CALCULATED AND RESPONSIVE BIDDER** with a bid offer of **One Million One Hundred Ninety One Thousand Four Hundred Sixty Eight Pesos & 60/100 Only (Php1,191,468.60)**.

**NOW THEREFORE**, in the consideration of the foregoing, We, the members of the Bids and Awards Committee, *hereby RESOLVE AS IT HEREBY RESOLVED* to:

1. Declare **VISION SECURITY SERVICES INC.**, as the Single Calculated and Responsive Bidder for the Security Services for ATI-RTC 8 & 4-H Learning Hub for the Period of February 1, 2024 – January 31, 2025;
2. Recommend for the approval of the Training Center Superintendent II of Agricultural Training Institute Regional Training Center 8 the foregoing findings and further recommend for the issuance of Notice of Award and Notice to Proceed to **VISION SECURITY SERVICES INC.**
