WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity has approved the Purchase Request (P.R.) No.'s:

- **01-2024-5-185** for General (F01) - *Two Million Four Hundred Seventy-Four Thousand Fifty Pesos (P2,474,050.00)*
- **07-2024-05-187** for CFIDP(F07)- *Four Hundred Fifty-Three Thousand Pesos (P453,000.00)*
- **03-2024-05-186** for RCEF (F03) with an amount *Eight Hundred Eighty Thousand Pesos (P880,000.00)*

with the total amount of Approved Budget for the Contract (ABC) of **Three Million Eight Hundred Seven Thousand Fifty Pesos (Php 3,807,050.00)** for Food Catering Services of ATI-RTC VIII Center-based Trainings/Activities for the 2nd semester of 2024 in accordance to the End-users Project Procurement Management Plan (PPMP).

WHEREAS, in response to the said posting, only **BAYBAY CITY CONSUMERS COOPERATIVE (BCCC)** bought the bidding documents from the BAC Secretariat.

WHEREAS, during the Bid Opening held on June 13, 2024, only one (1) bidder, **BAYBAY CITY CONSUMERS COOPERATIVE (BCCC)** submitted the bid proposal timely, and upon strict scrutiny and examination, it was found out that the prospective bidder qualified and complied based on the standards set forth; and was declared as the **SINGLE CALCULATED AND RESPONSIVE BIDDER** with a bid offer for General Fund (F01) is *Two Million Four Hundred Twenty One Thousand Three Hundred Forty Six Pesos Only (Php2,421,346.00)*; for Coconut Farmers and Industry Trust Fund (F07) is *Four Hundred Forty Three Thousand One Hundred Pesos (Php 443,100.00)*, and for Rice Competitiveness Enhancement Fund (F03) is *Eight Hundred Sixty Thousand Six Hundred Forty Pesos (P860,640.00)*.

NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, *hereby RESOLVE AS IT HEREBY RESOLVED* to:

1. Declare **BAYBAY CITY CONSUMERS COOPERATIVE (BCCC)** as the Single Calculated and Responsive Bidder for the Food Catering Services of ATI-RTC VIII Center-based Trainings/Activities for the 1st semester of 2024;
2. Recommend for the approval of the Training Center Superintendent II of Agricultural Training Institute Regional Training Center 8 the foregoing findings and further recommend for the issuance of Notice of Award and Notice to Proceed to **BAYBAY CITY CONSUMERS COOPERATIVE (BCCC)**.
