## **Invitation to Bid for the Construction of Swine Artificial Insemination sa Barangay (SWAIB) Facilities in Aguinaldo, Ifugao**

**ITB No: CB\_DA-ATI-RTC-CAR – 2024-001**

1. The **DA-Agricultural Training Institute-RTC-CAR (DA-ATI-RTC-CAR)**, through the *2024 General Appropriations Act* intends to apply the sum of **Three Million Three Hundred Fifty Thousand Pesos only (₱3,350,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract **Construction of Swine Artificial Insemination sa Barangay (SWAIB) Facilities in Aguinaldo, Ifugao, CB\_DA-ATI-RTC-CAR – 2024-001**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DA-ATI-RTC-CAR** now invites bids for the above Procurement Project. Completion of the Works is required *within 120 calendar days after receipt of NTP*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **DA-ATI-RTC-CAR** and inspect the Bidding Documents at the address given below from *8:30 AM-4:30 PM (PST), Monday to Friday, except Holiday*.
5. A complete set of Bidding Documents may be acquired by interested bidders during office hours on *June 21, 2024 to July 13, 2024, 10:00 AM (PST)*, from given address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (₱5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The **DA-ATI-RTC-CAR** will hold a Pre-Bid Conference on *July 2, 2024, 10:00 AM (PST)* at **DA-ATI-RTC-CAR, BSU Compound, La Trinidad, Benguet** and/or through videoconferencing *via Zoom, subject to request by prospective bidders/observers made at least a day before the schedule*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before *July 16, 2024, 10:00 AM (PST)*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on *July 16, 2024, 10:15 AM (PST)* at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

10. The **DA-ATI-RTC-CAR** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
