#### A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHOD OF PROCUREMENT – NEGOTIATED PROCUREMENT: SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES

Section 53.6 and Item V, Letter D, No. 6 of Annex "H" A of 2016 Revised IRR of RA 9184

**BAC Resolution No. ISD - 05-01, s. 2022**

**WHEREAS**, as a general rule, all procurements shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

**WHEREAS**, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

**WHEREAS**, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

**WHEREAS**, under Section 53 (Negotiated Procurement), Item No. 53.6 (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) allows procurement of goods, infrastructure project, and consulting services that can be contracted to a particular supplier, contractor or consultant and as determined by HOPE, which includes Media Services, among others, that covers media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

**WHEREAS**, the **INFORMATION SERVICES DIVISION** prepared a Purchase Request with **No. ISD (RICE) Fund 2022-04-14** for the **NEWS PAPER SPECIAL FEATURE ON RCEF AND RICE PROGRAMS AND SERVICES** with an Approved Budget for the Contract (ABC) of Php 1,200,000.00, in accordance with its PPMP to be awarded to two major broadsheet/ daily newspaper in the Philippine with the national scope/ circulation.

**WHEREAS**, the end-user conducted a market study/ research among three (3) major broadsheet for the procurement of **Media Services** which include documentation through negotiated procurement under Section 53.6 which is more efficient, economical and advantages to the government;

**WHEREAS**, The Manila Times submitted the lowest price quotation, while the Philippine Daily Inquirer and Manila Bulletin Publishing Corporation exceeded the unit cost in the approved budget proposal:



**NOW THEREFORE**, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

- 1. Recommend Alternative Method of Procurement through Negotiated Procurement – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as provided in Sec. 53.6 and Item V, Letter D, No. 6 of Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184; and**
- 2. Recommend the approval and award by the ATI Director of this Resolution and Purchase Order/Contract to THE MANILA TIMES PUBLISHING CORPORATION amounting to Three Hundred Fifty Thousand Pesos (Php 350,000.00).**
