A RESOLUTION DECLARING M.P. EVANGELISTA CATERING SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF MEALS DURING THE PRE-DEPARTURE ORIENTATION COURSE (PDOC) IN TAIWAN BATCH 2 (PHILGEPS REF. NO. 8732769/ ITB NO. ATI-CO-2022-10)

BAC Resolution No. OT- O3, s. 2022

WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act
“created the Bids and Awards Committee (BAC) to ensure among others that the
Procuring Entity abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass
through competitive bidding except as otherwise provided for under the Rule XIV;

WHEREAS, the **Procurement of Meals for the Pre-Departure Orientation Course (PDOC) of the
Filipino Young Farmers Internship Program (FYFIP) in Taiwan Batch 2**, not being
an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the
aforementioned Project with Approved Budget for the Contract Amounting to **One Million
One Hundred Twenty-Two Thousand Pesos (Php 1,122,000.00)** in PhilGEPS Website
(PHILGEPS REF. NO. 8732769/ ITB NO. ATI-CO-2022-10) and the ATI Website.

WHEREAS, in response to the said posting, two (2) prospective bidders bought the bidding
documents from the BAC Secretariat and submitted their bid proposals before the bid
opening held on June 27, 2022;

1. Meyer’s Foods and Services
2. M.P. Evangelista Catering Services

WHEREAS, during the Bid Opening, it was found out that Meyer’s Foods and Services submitted only
the Philgeps Registration;

WHEREAS, Section VIII, Checklist of Technical and Financial Documents of the Bidding Document
states that:

I. TECHNICAL COMPONENT ENVELOPE

Class “A” Documents

Legal Documents

- (a) Valid PhilGEPS Registration Certificate (Platinum Membership) (all
pages);
or
- (b) Registration certificate from Securities and Exchange Commission (SEC),
Department of Trade and Industry (DTI) for sole proprietorship, or
Cooperative Development Authority (CDA) for cooperatives or its
equivalent document,
and
- (c) Mayor’s or Business permit issued by the city or municipality where the
principal place of business of the prospective bidder is located, or the
equivalent document for Exclusive Economic Zones or Areas;
and
- (d) Tax clearance per E.O. No. 398, s. 2005, as finally reviewed and approved
by the Bureau of Internal Revenue (BIR).

WHEREAS, Meyer's Foods and Services did not comply with all of the eligibility requirements, and rated as "INELIGIBLE" to proceed to the opening of the Financial Envelope;

WHEREAS, M.P. Evangelista Catering Services complied with all the eligibility/technical and financial requirements, and rated as "ELIGIBLE" to participate in the bidding and thus rated as "PASSED" with a Bid Amount as Read amounting to Eight Hundred Fifty Thousand Eight Hundred Fifty Pesos (PhP 850,850.00);

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation and verification of all eligibility documents, technical and financial documents required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations and found M.P. Evangelista Catering Services to be "Responsive" to ATI's requirements (*see attached Bid Evaluation Report and Post Qualification Report of BAC TWG*) with a Bid Amount as Calculated amounting to Eight Hundred Fifty Thousand Eight Hundred Fifty Pesos (Php 850,850.00);

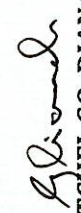
WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declare **M.P. Evangelista Catering Services** as the **LOWEST CALCULATED AND RESPONSIVE BIDDER**;

NOW, THEREFORE, in consideration of the foregoing, We, the Members of the Bids and Awards Committee, *hereby RESOLVE AS IT HEREBY RESOLVED* to:

1. Declare **M.P. Evangelista Catering Services** as the **LOWEST CALCULATED AND RESPONSIVE BIDDER** for the **Procurement of Meals for the Pre-Departure Orientation Course (PDOC) of the Filipino Young Farmers Internship Program (FYFIP) in Taiwan Batch 2**;
2. Recommend for the approval of award of the said Contract to **M.P. Evangelista Catering Services** and its Bid Amount as Calculated amounting of **Eight Hundred Fifty Thousand Eight Hundred Fifty Pesos Only (Php 850,850.00)**;
3. Recommend for the Approval by the ATI Director IV the foregoing findings/recommendations.
