A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING AN ALTERNATIVE METHOD OF PROCUREMENT – NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AND AWARD TO MEYER'S FOODS AND SERVICES INC.

- WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity had approved Purchase Request (P.R.) No. CDMD FUND 2022-10-25 to procure meals during the conduct of two batches of Training Module Development at the RDEC, ATI Compound QC with an Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos (Php 150,000.00) in accordance with the End-user's Project Procurement Management Plan (PPMP);
- **WHEREAS**, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;
- **WHEREAS**, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;
- WHEREAS, the above-cited Purchase Request to procure meals during the conduct of two batches of Training Module Development at the RDEC, ATI Compound QC, is not covered by Shopping under Section 52 of the IRR of RA 9184;
- WHEREAS, the amount involved is within the threshold of Negotiated Procurement Small Value Procurement as an Alternative Method of Procurement indicated in Annex "H" of the 2016 Revised IRR of RA 9184 for National Government Agencies (NGA's);
- **WHEREAS**, the receipt of one (1) quotation/proposal is sufficient to proceed with the evaluation thereof;
- WHEREAS, based on the Purchase Request of the End-User for the catering services, the Module Development Training will be conducted in two (2) batches, November 14-18 and November 21-25, 2022 to be held at RDEC Training Hall, Quezon City, however due to several activities booked at RDEC, only the training hall, and rooms for batch 1 will be accommodated.
- **WHEREAS**, batch 2 of the said activity will be held outside the ATI facilities, hence the request for the catering service for November 21-25, 2022 will be cancelled; (see attached end-user justification);
- **WHEREAS**, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;

WHEREAS, ATI-BAC shall validate the technical, legal, and financial capability of the supplier/s bysubmission of relevant documents or through other means of exercising due diligence prior to the recommendation of award to the Head of Procuring Entity (HOPE).

NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE AS IT HEREBY RESOLVED:

- 1. Recommend Alternative Method of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of 2016 Revised IRR of RA 9184 for the above-cited goods/services/infrastructure projects/consulting services; and
- 2. Recommend the approval and award by the ATI OIC-Director IV of this Resolution and Purchase Order/Contract to MEYER'S FOODS AND SERVICES INC. for Batch 1 of Module Development Training (November 14-18, 2022) amounting to One Hundred Eighteen Thousand Seven Hundred Fifty Pesos (Php 118,750.00).
