A RESOLUTION RECOMMENDING APPROVAL FOR THE AMENDMENT OF THE BAC RESOLUTION NO. PAD-09-02, SERIES OF 2022 RE: A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHODS OF PROCUREMENT – NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AND AWARD TO ANTHONY'S RESTAURANT

WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity had approved Purchase Request (P.R.) No. PAD (RCEF) FUND 2022-09-46 to procure meals to be served during the 4th RCEF Convergence Workshop on September 18-20, 2022 with an Approved Budget for the Contract (ABC) of **Ninety-Nine Thousand Pesos (PHP 99,000.00)** in accordance with the End-user's Project Procurement Management Plan (PPMP);

WHEREAS, the said procurement will be awarded to the lowest bidder which is Anthony's Restaurant amounting to Seventy Eight Thousand Two Hundred Ten Pesos (Php. 78,210.00);

WHEREAS, the 4th Convergence Workshop was rescheduled from September 18-20, 2022 to October 26-27, 2022;

WHEREAS, last October 24, 2022, Mr. Ace Marcos (end-user) coordinated the supplier for the arrangement of the serving of the meals and signing of the Purchase Order and Notice of Awards, however, Ms. Queene Victoria K. Aurello representative of Anthony's Restaurant declined to sign the documents due to bulk orders and conflict of schedule;

WHEREAS, due to the refusal/decline of Anthony's Restaurant to sign the Purchase Order and Notice of Awards, Anthony's Restaurant is not a responsive bidder for the transaction;

WHEREAS, the procurement of meals for the said activity will be awarded to MP Evangelista Catering Services as the second lowest and responsive bidder amounting to Eighty-Five Thousand Five Hundred Pesos (Php 85, 500.00);

NOW, **THEREFORE**, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED**:

1. Recommend the approval and award by the ATI OIC-Director IV of this Resolution and Purchase Order/Contract to the second lowest and responsive bidder, **M.P. Evangelista Catering Services amounting to Eighty-Five Thousand Five Hundred Pesos (Php 85,500.00).**
