WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act “created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the IRR of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the **Procurement of Service Vehicle (Re-Bid)**, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract Amounting to **Five Million Eight Hundred Fifty Thousand Pesos (Php 5,850,000.00)** on PhilGEPS Website (PHILGEPS REF. NO. 9192509/ ITB NO. ATI-CO-2022-15) and the ATI Website;

WHEREAS, in response to the said posting, only Toyota Marilao, Bulacan Inc. submitted their bid proposal during the bid opening held on November 28, 2022;

WHEREAS, during the Bid Opening, it was found that having complied with all the eligibility/ technical and financial requirements, bidders were rated as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**”;

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents, technical and financial documents required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations (see attached TWG’s Bid Evaluation Report and Post- Qualification Report);
