**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act “created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

**WHEREAS**, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

**WHEREAS**, the **PROCUREMENT OF SERVICE PROVIDER FOR THE SHORT COURSE ON LEADERSHIP AND MANAGEMENT**, not being an exemption, must necessarily pass through competitive bidding;

**WHEREAS**, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract Amounting to **Six Million Eight Hundred Seventy-Three Thousand Pesos (Php 6,873,000.00)** in PhilGEPS Website (PHILGEPS REF. NO. 9294437/ ITB NO. ATI-CO 2022-17) and the ATI Website.

**WHEREAS**, in response to the said posting, only the Asian Institute of Management (AIM) bought the bidding documents from the BAC Secretariat and submitted their bid proposals during the bid opening held on December 19, 2022;

**WHEREAS**, during the Bid Opening, the AIM complied with all the eligibility/technical and financial requirements, and was rated as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**”;




