#### A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHOD OF PROCUREMENT – NEGOTIATED PROCUREMENT: SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES

Section 53.6 and Item V, Letter D, No. 6 of Annex "H" A of 2016 Revised IRR of RA 9184

BAC Resolution No. ISD - 18- 6, s. 2022

**WHEREAS**, as a general rule, all procurements shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

**WHEREAS**, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

**WHEREAS**, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

**WHEREAS**, under Section 53 (Negotiated Procurement), Item No. 53.6 (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) allows procurement of goods, infrastructure project, and consulting services that can be contracted to a particular supplier, contractor or consultant and as determined by HOPE, which includes Media Services, among others, that covers media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

**WHEREAS**, the **INFORMATION SERVICES DIVISION** prepared a Purchase Request with No. **ISD (CFIDP) Fund 2022-12-66** for the **PUBLICATION OF ADMINISTRATIVE CIRCULAR ON THE GUIDELINES FOR HE IMPLEMENTATION OF THE COCONUT-BASED COFFEE AND/OR CACAO ENTERPRISE DEVELOPMENT PROJECT (C3EDP)** with an Approved Budget for the Contract (ABC) of **Php 411,264.00**, to be awarded to two major broadsheets/daily newspaper in Philippines with the national scope/circulation in accordance with its PPMP;

**WHEREAS**, the end-user justifies based on their market study/research that procurement of **Media Services** which include documentation and airing through negotiated procurement under Section 53.6 is more efficient, economical and advantages of the government;

**NOW THEREFORE**, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. **Recommend Alternative Method of Procurement through Negotiated Procurement – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services as provided in Sec. 53.6 and Item V, Letter D, No. 6 of Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184;**
