- WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act "created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;
- **WHEREAS**, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;
- WHEREAS, the PROCUREMENT OF PROVIDER OF MEALS DURING THE PRE-DEPARTURE ORIENTATION COURSE (PDOC) OF YOUNG FILIPINO FARM LEADERS TRAINING PROGRAM IN JAPAN (YFFLTPJ) BATCH 2023, not being an exemption, must necessarily pass through competitive bidding;
- WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with Approved Budget for the Contract Amounting to One Million Six Hundred Eleven Thousand Three Hundred Pesos (Php 1,611,300.00) in PhilGEPS Website (PHILGEPS REF. NO. 9423236/ITB NO. ATI-CO-2023-03) and the ATI Website.
- WHEREAS, in response to the said posting, two (2) prospective bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals before the bid opening held on February 13, 2023;
- WHEREAS, during the Bid Opening, it was found out that having complied with all the eligibility/ technical and financial requirements, bidders were rated as" ELIGIBLE" to participate in the bidding and thus rated as "PASSED";
