## A RESOLUTION DECLARING SONKKENS OFFICE EQUIPMENT TRADING AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF PAPER S AND PAPER PRODUCTS

- WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act "created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;
- **WHEREAS**, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;
- WHEREAS, the Procurement of Papers and Paper Products, not being an exemption, must necessarily pass through competitive bidding;
- WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with Approved Budget for the Contract Amounting to Two Million Seven Hundred Thirty-One Thousand Seven Hundred Ninety-Five Pesos (Php 2,731,795.00) in PHILGEPS Website (PHILGEPS REF. NO. 9403296/ ITB NO. ATI-CO 2023-02) and the ATI Website.
- WHEREAS, in response to the said posting, only one (1) prospective bidder bought the bidding documents from the BAC Secretariat and submitted their bid proposal during the bid opening held on February 2, 2023;
- WHEREAS, during the Bid Opening, it was found out that SONKKENS OFFICE EQUIPMENT TRADING complied with all the eligibility/technical and financial requirements, and rated as "ELIGIBLE" to participate in the bidding and thus rated as "PASSED";
- WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents, technical and financial documents required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations; and found it to be "Responsive" to ATI's requirements (see attached Bid Evaluation Report and Post Qualification Report of BAC TWG);
- WHEREAS, the Bid Amount as Calculated of SONKKENS OFFICE EQUIPMENT TRADING is Two Million Six Hundred Eighty-Two Thousand One Hundred Seventy-Eight Pesos (Php 2,682,178.00);

- 3. Recommend for Approval by the ATI OIC-Director IV the foregoing findings/recommendations.
