- Clubhouse sandwiches with filling of any of the following combination: ham with egg and tomato, ham with cheese and coleslaw, hotdog and cheese, tuna with coleslaw, chicken with coleslaw etc. (at least 3 layers)
- Dim sum-style meals (at least 100 grams per serving)
- Congee or lugaw or Arrozcaldo (at least ¾ full of medium-sized bowl) with egg
- Supplier's kitchen, food preparation or cooking area must be identified and is within Quezon City to ensure freshness of meals being served.
- The procuring entity reserves the right to inspect the supplier's kitchen or food preparation area to ensure quality of food and to enforce health protocols.
- The service provider must assign a contact person that will deal with the ATI request. The contact person must be available via phone at all times at working hours.
