- WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity had approved Purchase Request (P.R.) No. CDMD FUND 2023-03-20 meals during the conduct of Capability Building on Writing on Purposive Training and Activity Designs on April 18-20, 2023 at RDEC ATI Compound Elliptical Road Diliman Quezon City with an Approved Budget for the Contract (ABC) of One Hundred Eight Thousand Pesos (Php 108,000.00) in accordance to the End-users Project Procurement Management Plan (PPMP);
- WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions to promote economy and efficiency, may resort to any alternative method of procurement;
- WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;
- WHEREAS, the above cited Purchase Request for meals during the conduct of Capability Building on Writing on Purposive Training and Activity Designs on April 18-20, 2023 at RDEC ATI Compound Elliptical Road, Diliman Quezon City, is not covered by Shopping under Section 52 of the IRR of RA 9184;
- WHEREAS, the amount involved is within the threshold of Negotiated Procurement Small Value Procurement as an Alternative Method of Procurement indicated in Annex "H" of the 2016 Revised IRR of RA 9184 for National Government Agencies (NGA's);
- WHEREAS, the receipt of one (1) quotation/proposal is sufficient to proceed with the evaluation thereof;
- **WHEREAS**, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;
- WHEREAS, ATI-BAC shall validate the technical, legal, and financial capability of the supplier/s by submission of relevant documents or through other means of exercising due diligence prior to the recommendation of award to the Head of Procuring Entity (HOPE).
