**A RESOLUTION DECLARING DEOKMA EIGHT TRADING INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF BRAND NEW AIR CONDITIONING**

**(PhilGEPS REF. No. 9378450/ ITB-ATI-CO-2022-18)**

**BAC Resolution No. 04-01, s. 2023**

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

**WHEREAS**, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

**WHEREAS**, the **Procurement of the Brand New Air-conditioning Units**, not being an exemption, must necessarily pass through competitive bidding;

**WHEREAS**, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with Approved Budget for the Contract (ABC) amounting to **One Million Three Hundred Twenty-Five Thousand Six Hundred Forty Pesos (Php 1,325,640.00)** in PhilGEPS Website (PhilGEPS REF. No. 9378450/ ITB-ATI-CO-2022-18) and the ATI Website.

**WHEREAS**, in response to the said posting, only Deokma Eight Trading Inc. bought the bidding documents from the BAC Secretariat, and submitted their bid proposal before the bid opening held on January 30, 2023;

**WHEREAS**, Deokma Eight Trading Inc. complied with all the eligibility/technical and financial requirements, were rated as “**ELIGIBLE**” to participate in the bidding and thus was rated as “**PASSED**”;

**WHEREAS**, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation and verification of all eligibility documents, technical and financial documents required, including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations; and found Deokma Eight Trading Inc. to be “**Responsive**” to ATI’s requirements (see attached Bid Evaluation Report and Post Qualification Report of BAC TWG);

**WHEREAS**, Deokma Eight Trading Inc. Bid Amount as Calculated is One Million Two Hundred Fifty-Eight Thousand Pesos (PHP 1, 258,000.00)

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation.





**NOW, THEREFORE**, in consideration of the foregoing, We, the Members of the Bids and Awards Committee, **hereby RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare **Deokma Eight Trading Inc.** as the **SINGLE CALCULATED AND RESPONSIVE BIDDER** for the Procurement of Brand New Air-conditioning Units;

- 2. Recommend the approval of award of the said Contract to **Deokma Eight Trading Inc.** amounting to **One Million Two Hundred Fifty-Eight Thousand Pesos (Php 1,258,000.00)**;
- 3. Recommend the approval by the ATI Director IV the foregoing findings/ recommendations.
